



HISTORICAL OVERVIEW

Greenwood Heights gets its name from the prominent Green-Wood Cemetery, which predates the Brooklyn Bridge. Founded in 1838, the cemetery spans 478 acres and is a testament to Gothic Revival architecture. It was once a popular tourist destination in the 19th century, attracting more visitors than Niagara Falls. 
